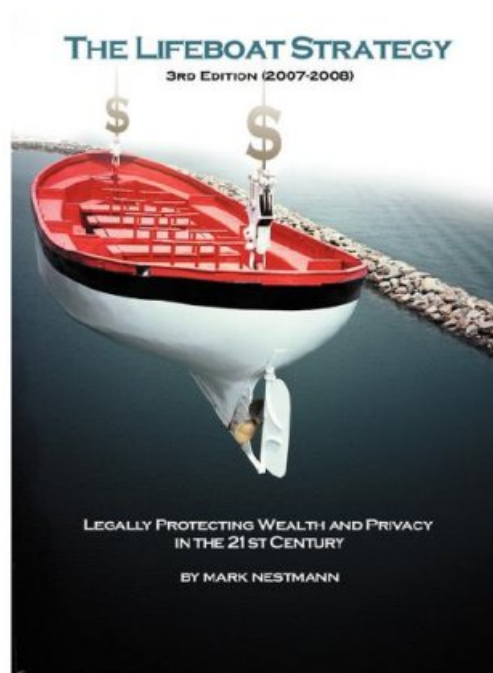
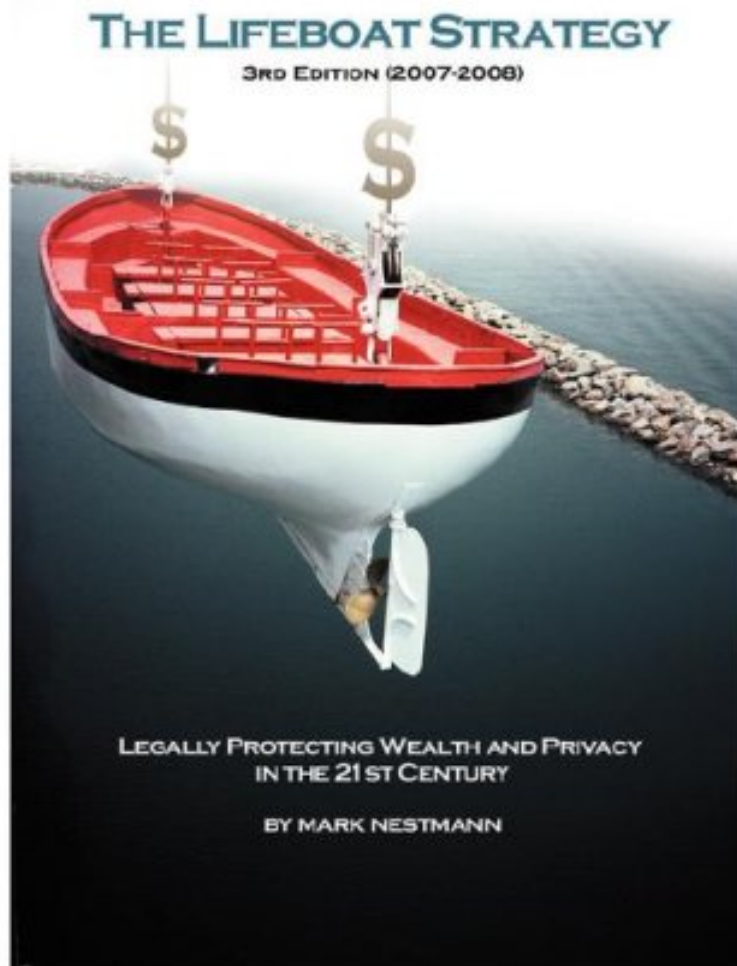

There is a new edition that you can find on the author's website for significantly more money, in three volumes.
